Fatigue, stress, emotions and illnesses create distractions that interfere with judgement and aeronautical situational awareness. Pilot's reaction timing and accuracy may be greatly

affected.

Rehabilitation from illness or surgery can be a critical time for the pilot alertness, observations, ability to evaluate risk factors and to react in timely ways to cope with hazards.

Especially following most surgeries, medications are prescribed and over-the-counter medications may be used to reduce pain. Some often may cause you to go off to "Goofy City". You may suffer some memory loss, possible disorientation, constipation and possibly jitters, or other side effects.

The effect of pain killers is not confined to the area of pain but will affect your entire nervous system to some extent. The eyes and brains are the most complex systems of nerves in your entire body. When they are effected, guess what? You shouldn't fly until the drug effects have had time to wear off.

If you have the slightest doubt about the effects that any drug may have on your ability to fly safely --- The AOPA (Aircraft Owners and Pilots Association) or EAA Experimental Aircraft Association) has a great medical section for suggestions about how to proceed. Learning what medications you take may have an effect on flying and you not know it.

If you have ever had anti-depressant medication prescribed or have ever been treated for Attention Deficient Disorder be sure to have a consultation with the FAA Airman Examiner before entering any FAA paperwork or going on line prior to taking a

In late September I went to the FAA web site to read the requirements. Then I talked to James at General Avionics about installing a Garmin 345 and FS210, got an install date and registered for the rebate. This involved filling out a simple form and receiving a confirmation via email from the FAA with a reservation code and a date to complete installation and testing of the system. I thought, so far so good.

I got a TSO-certified system, then flew the test flight. The test flight must be conducted in the 'Rule Airspace" for 30 minutes. The FAA has some suggested guidance maneuvers to ensure position and that the system was transmitting in various altitudes and turns. This seemed straight forward. I did a test flight with a co-pilot, one

On October 4, 2016, about 1827 central daylight time, a Beechcraft D95A "Travel Air", multi-engine airplane, N76S, was substantially damaged after impacting trees and terrain while maneuvering near Dickinson, Texas. The flight instructor was fatally injured and the pilot receiving instruction was seriously injured. The airplane was maneuvering about 4,800 feet above ground level (agl) when it slowed and began descending rapidly. A witness about one-mile south took a cell-phone video which showed the airplane descending rapidly in a fully developed spin. The airplane did not recover from the. Frankowski Continued from page 1 to fly and one to see if equipment was working as expected and be safety pilot. We departed IWS, flew west to be outside the shelf of class "B" airspace. Then we did turns, climbs and descents, a practice GPS approach into TME and a practice GPS 15 approach into IWS. We were airborne over and hour and 20 minutes. Test done; or so I thought., I emailed the addresses given on the registration form to request. Public ADS-B Performance Report (PAPR). Since I was applying for the \$500.00 rebate I would get a PAPR report and a GA Incentive Requirements Status Report. I received both reports in about 30 minutes.

The reports showed the equipment passed but I had failed one of the Rebate Rules. Under Detected in Rule Airspace it stated, "The Performance Monitor could NOT validate that the flight operation consisted of at least 30 minutes in the airspace defined in 14 CFR 91.225." and indicated that I had only spent 22 minutes in the "Rule Airspace".

I immediately looked up 14 CFR 91.225.

I am sure some of you have already figured out what I did wrong. Class "E" airspace under 10,000 is not part of the "Rule Airspace".

Happy Ending: We redid our test flight using flight following under the Class "B" shelf and in Class "B" airspace or with-in 30 miles of Class "B" airport". So as not to waste a flight we did practice approaches into Sugarland and Hooks being sure to fly more than the 30 minutes required. This time we passed. I don't think it is necessary to have flight following, but needed ATC to do the practice approaches.

Once you had passed the flight test per the rebate rules you get a report with another code. To claim the rebate, go back to the FAA rebate site and fill out another short form with the codes. FAA will then send an email saying your rebate has been approved and will receive rebate check in 4 to 6 weeks.

If you have not installed ADS-B out equipment but know what you want now is the time to do it. Just remember to do the test within the "Rule Airspace". For more information go to: http://www.faa.gov/nextgen/equipadsb/rebate


